Enforceable Obligation is Right of Entry Agreement and Temporary Construction Easement dated 6/27/2009 for a street improvement project in Mecca. Agency needed to remove an overhang from the 99cent Store which was encroaching on the county road right of way in order to begin the street improvements. Owner agreed to the terms of the Right of Entry Agreement with the condition that the Agency would assist her with repairing the damage from removal of the overhang through the Facade Improvement Program. The Right of Entry Agreement states, "Agency shall remedy such damage with due diligence and replace or reconstruct with like kind" any damage done to the structure during the course of the demolition. The street improvements are now complete and the Agency wishes to fulfill the terms of the Right of Entry Agreement.
