**Meeting Date:** September 17, 2015

**Action:** **Adoption of the Recognized Obligation Payment Schedule and Successor Agency Administrative Budget for the Period of January 1, 2016 through June 30, 2016, via Resolutions 2015-008 and 2015-009 – Successor Agency Item 4-2, of September 15, 2015**

**Background:**

Pursuant to California Health and Safety Code Section 34177(j) and 34177(l), Successor Agencies are required to prepare a proposed administrative budget and a Recognized Obligation Payment Schedule (“ROPS”) and submit it to the Oversight Board for approval.

Oversight Board Resolution No. 2015-008 includes Exhibit “A, which is the ROPS 15-16B for the January 1, 2016 through June 30, 2016 fiscal period.

Oversight Board Resolution No. 2015-009 addresses the Successor Agency’s Administrative Budget, and includes Exhibit “A”, which provides the estimated administrative cost for the January through June 2016 fiscal period, and serves as a summary of the direct and indirect costs for the given fiscal period.

The outstanding obligations by funding source for the January through June 2016 ROPS are as follows:

A. Available Revenues Other Than Anticipated RPTTF Funding	1,644,759
B. Enforceable Obligations Funded with RPTTF	23,285,862
C. Enforceable Obligations Funded with Reserve Funds	9,351,000
D. Administrative Allowance funded with RPTTF	<u>678,229</u>
E. Total RPTTF Requested (B+D=E)	34,281,621

On September 15, 2015, the Board of Supervisors for the County of Riverside, as the governing body of the Successor Agency to the Redevelopment Agency for the County of Riverside, approved ROPS 15-16B and the Successor Agency’s Administrative Budget for the period of January 1, 2016 through June 30, 2016, as Item 4-2.

**Recommendation:** Staff recommends that the Oversight Board for the Successor Agency to the Redevelopment Agency for the County of Riverside adopt the ROPS 15-16B and the Successor Agency Administrative Budget for the fiscal period of January 1, 2016 through June 30, 2016, via Resolutions 2015-008 and 2015-009.

**Action:** **Approval and Adoption of the Amended Long-Range Property Management Plan, via Resolution 2015-010 – Successor Agency Item 4-1, of September 15, 2015**

**Background:**

The Successor Agency to the Redevelopment Agency for the County of Riverside originally submitted the LRPMP to the Department of Finance (DOF) on October 1, 2014. After initial DOF review, in May 2015, DOF notified the Successor Agency that the properties identified for transfer for governmental use are not developed and therefore do not qualify for that category, pursuant to HSC Section 34181. The properties in question are listed below:

In lieu of transfer, the Successor Agency is requesting for these properties to be placed in the “retain for future development” category.

In accordance with the requirements of Health and Safety Code Section 34180 (f), staff is prepared to reach a compensation agreement with the affected taxing entities for those properties for future development activities. The Agency will provide payments to them in proportion to their shares of the base property tax, as determined pursuant to Section 34188, for the value of the property retained.

In addition, DOF directed the Successor Agency to conduct appraisals on all properties. The appraisal of all properties were undertaken by a certified appraiser, and the values are shown in each property profile.

The attached amended LRPMP shows that the Agency is the owner of record of 87 Assessor Parcel Numbers, amounting to approximately 639 acres of land. The table below shows a summary of the use and disposition strategy for the parcels, based on the permissible categories as set forth in Health and Safety Code Section 34191.5.

The Agency received its Finding of Completion (FOC) from the State Department of Finance (DOF) on April 18, 2014. Pursuant to Health and Safety Code Section 34191.5, six months after receiving the FOC from the DOF, the Agency submitted its LRPMP to the Oversight Board and DOF for review and approval October 2014.

On September 15, 2015, the Board of Supervisors for the County of Riverside, as the governing body of the Successor Agency to the Redevelopment Agency for the County of Riverside, approved the amended LRPMP via Agenda Item 4-1.

**Recommendation:** Staff recommends that the Oversight Board for the Successor Agency to the Redevelopment Agency for the County of Riverside approve and adopt the Long-Range Property Management Plan, via Resolution 2015-010.

9 **WHEREAS**, redevelopment agencies were dissolved as of February 1, 2012, following  
10 a California Supreme Court ruling in *California Redevelopment Association v. Matosantos*  
11 upholding Assembly Bill x1 26 (“ABX1 26”); and

12 **WHEREAS**, the Successor Agency to the Redevelopment Agency for the County of  
13 Riverside (Successor Agency) is responsible for implementing ABX1 26; and

14 **WHEREAS**, provisions of ABX1 26 require that each Successor Agency have an  
15 oversight board to oversee and review the actions of the Successor Agency as it winds down  
16 the affairs of the former Redevelopment Agency; and

17 **WHEREAS**, an oversight board has been formed, pursuant to Health and Safety Code

19 **WHEREAS**, AB 1484 was enacted in June 2012, requiring all successor agencies for  
20 the former redevelopment agencies that owned property at the time of the dissolution in 2011  
21 to prepare a Long-Range Property Management Plan (LRPMP) that addresses the disposition  
22 and use of the identified real properties vested under the former redevelopment agency for  
23 consideration by the Oversight Board and the Department of Finance (DOF) for purposes of  
24 administering the winding down of redevelopment activity;

25 **WHEREAS**, pursuant to Health and Safety Code Section 34191.5(c), the LRPMP shall  
26 include an inventory of all properties owned by the former Redevelopment Agency for the  
27 County of Riverside at the time of dissolution, and provide recommendations for appropriate  
28 means of disposal and use of each parcel as identified in the LRPMP;

1           **WHEREAS**, the Successor Agency received it's Finding of Completion (FOC) from the  
2           DOF on April 18, 2014;

3           **WHEREAS**, pursuant to Health and Safety Code Section 34191.5 (b) the LRPMP was  
4           submitted to the Oversight Board on September 18, 2014 and to the and DOF October 1,  
5           2014;

6           **WHEREAS**, the DOF requested clarification regarding certain properties and a change  
7           in the permissible use for those properties under the Governmental Use category;

8           **NOW, THEREFORE, BE IT RESOLVED, FOUND, AND DETERMINED** by the  
9           Oversight Board for the Successor Agency to the Redevelopment Agency for the County of  
10          Riverside as follows:

11          1. The Oversight Board approves and adopts the amended Long-Range Property  
12          Management Plan in substantially the form attached hereto as Exhibit A, as required by  
13          Health and Safety Code Section 34191.5.

14          2. The Board Clerk shall electronically transmit this resolution to the Department of  
15          Finance as required pursuant to Health and Safety Code Section 34179(h).

16          3. Pursuant to Health and Safety Code Section 34177(m), the Department of Finance  
17          shall make its determination of the enforceable obligations and the amounts and funding  
18          sources of the enforceable obligations no later than 45 days after the Recognized Obligation  
19          Payment Scheduled is submitted. Pursuant to Health and Safety Code Section 34179(h), all  
20          actions taken by the Oversight Board may be reviewed by the State of California Department
